

## Website Terms of Use

This website ([www.calrec.com](http://www.calrec.com)) (the “**Website**”) is owned and operated by [Calrec Audio Limited](#) (“**Calrec**”, “**we**”, “**us**”, or “**our**” as the context dictates), a company incorporated in England and Wales under company number [02392336](#), and having its registered office at [Nutclough Mill, Victoria Road, Hebden Bridge, West Yorkshire, HX7 8EZ, UK](#).

These terms (“**Terms**”) govern your use of the Website. Please read them carefully before you use the Website. If you do not accept them, please discontinue your use of the Website with immediate effect. By continuing to use the Website, you accept and agree to be bound by these Terms.

These Terms are occasionally updated, and any changes will take effect upon posting to the Website. It is your responsibility to keep abreast of changes so please refer back to them in the future.
